- **ELIGIBILITY FOR ENDOCRINOLOGY** - Desired qualification is MD/DNB in Medicine or Paediatrics.
- **ELIGIBILITY FOR HAEMATOLOGY** - The candidate should possess MD or equivalent in Medicine or Paediatrics. Candidate with M.D. or equivalent in Pathology will not be eligible.
- **ELIGIBILITY FOR MAXILLOFACIAL SURGERY** - The candidate should possess MDS or Equivalent in Oral and Maxillofacial Surgery.
